PO Medina also called [REDACTED] [REDACTED] a "motherfucker" and called him a "dick sucker" in Spanish. PO Harrington also called [REDACTED] [REDACTED] a "motherfucker." [REDACTED] [REDACTED] stated that he had scratches on his hand neck and chin, and his back was aggravated "from the blows that he received from PO Medina and PO Harrington."
