## Initial Complaint Narrative

---

[REDACTED] was leaving the building of a woman he was visiting, [REDACTED] (unrelated), when PO1 stopped him and asked where he was coming from. Officers had already apprehended two people outside of the building. [REDACTED] stated that he was coming from the building. PO1 instructed [REDACTED] to put his hands against the wall, and he complied. PO1 then stated that [REDACTED] was trespassing, and [REDACTED] stated that PO1 could speak to the woman in the building to confirm that he was not. Two or three other officers (PO2 and PO3 described below) then approached and they and PO1 brought [REDACTED] him to the ground, face forward. He felt pressure on his back, either knees or fists, and was handcuffed. [REDACTED] has a pin in his left wrist from previous reconstructive surgery, and he asked the officers to "ease up," but was told to "shut the fuck up." He was then taken to the precinct in a marked white police van driven by PO3 with a number of other individuals who had been arrested. All the officers were in the van. At some point, an officer informed [REDACTED] that they were performing "an unlimited sweep arrest," or something to that effect. At the precinct, [REDACTED] was processed by PO4, shield #23, who was in the front passenger seat of the van. PO4 was not one of the officers who apprehended [REDACTED]. PO4 later asked [REDACTED] to take off his jacket, pull his pants down and bend over. [REDACTED] complied. [REDACTED] was charged with [REDACTED] and held for two days. His case is still pending. He was also issued two summonses for [REDACTED], which were later dismissed. [REDACTED] phone number is [REDACTED]. She did not witness the incident. PO1 - light-skinned black male, late-twenties, about 6 feet tall, muscular. (second row) PO2 - white male, glasses, 6'1, 240 lbs, late-twenties, black hair PO3 - white male, late twenties (Driver) PO4 - black male, bald, mid-twenties, 5'11, medium build, shield #23 (front passenger) All officers were wearing blue fatigue pants and blue sweaters. Note: This intake tape malfunctioned somehow and the narrative is virtually inaudible, but it was accurately transcribed as [REDACTED] recounted it.
