Initial Complaint Narrative

██████████ entered a store and got change while her friend waited for her in a vehicle outside. While returning to the vehicle from the store, two uniformed officers approached from a RMP. The officers asked persistently about what she had bought in the store, suggesting that it was drugs. She denied that accusation and showed them what were in her pockets. PO1, who ██████████ identified as Officer Hobson, was undressing her with his eyes. ██████████ showed him her ID. They continued to ask if she had bought drugs. PO Hobson told her something about someone buying cocaine on the corner. PO2 was speaking with her "partner", it was unclear on the initial intake who that was. ██████████ described the officers as unprofessional and disrespectful. She further stated that when she was back in the vehicle, PO Hobson was asking whether she was warm or not because she was taking off items of clothing. Officer Hobson: 5'9", Black, light skin, short, stocky. PO2: 5'9" - 5'10", White, short, stocky.
