Initial Complaint Narrative

██████████ stated he called to file this complaint in January but the investigator was not able to locate a complaint in CTS. ██████████ claimed he left a message and someone called him back from the CCRB to ask him questions and stated they would be in contact with him but had not heard from anyone in two months. ██████████ stated he answered all these questions already when he filed the complaint the first time. ██████████ did not know the exact date he called to file the complaint. ██████████ was double parked on ██████████ and was in the front passenger seat. A marked police car pulled up and asked ██████████ what he was doing here. ██████████ went into the driver's seat and rolled down the window. PO1 (male/Hispanic, uniform) told ██████████ to get out of the car and he did. ██████████ showed him his security license because his license was suspended. PO1 arrested him and put cuffs on his hand. ██████████ has no feeling in his right hand. ██████████ was slammed into the police car and the ground. ██████████ had a headache and bruises. ██████████ was taken to ██████████ hospital in the Bronx. ██████████ claimed the doctors did not note any of his injuries other than his head. There were numerous officers that threw him to the ground because the officers called for back-up. ██████████ was arrested for DWI although he was not driving.
