## Initial Complaint Narrative

\*This case is a duplicate of [REDACTED] which was referred by IAB and sent back to IAB because at that time no civilian filed a complaint.\* The narrative of the original referral follows: Sgt Mainor, stated that he is assigned to the [REDACTED] detail tonight. At 2025 hrs POM Harrington, and POM Medina were assigned to a park at [REDACTED] and were instructed not to permit any alcohol into the park. [REDACTED] became irate, challenging and confrontational towards the officers when they explained that no alcohol was permitted in the area and began to punch them when they requested to inspect his packages for alcoholic beverages. He was overcome, arrested and transported to [REDACTED] Hospital after being struck on the leg with an ASP baton.\*\*\*\*\*Narrative of complaint [REDACTED] was going to celebrate the 4th of July in a park on [REDACTED]. Two officers told him he could not come into the park with alcohol. [REDACTED] stated that he did not have alcohol in his bag, then dropped a bag of ice. Both officers got into a dispute with [REDACTED] then began striking him all over his body with their hands and batons. [REDACTED] was arrested and charged with [REDACTED]. He was taken to the 7th Precinct but believed that both PO1 and PO2 were from a Bronx precinct and were working a 4th of July detail in Manhattan, based on their statements. [REDACTED] suffered severe bruises and cuts to both legs, a black left eye and a bloodshot right eye, and pain to his lower back when PO1 sat on him while handcuffing him. He stated that he had a bad back. There were four or five other officers nearby, including PO3, who he believed was PO1 and PO2's supervisor because he seemed to be issuing them orders. [REDACTED] was taken to [REDACTED] Hospital. [REDACTED] has a videotape of this incident that was recorded by a friend and also stated that he has documented his injuries, which are still visible. PO1: Black male, 5'9", 200 pounds, black hair, no facial hair, wearing glasses, mid-late 20s, in uniform. Named "Huntington" or something similar. PO2: Hispanic male, 5'7", 180 pounds, bald/shaved head, no facial hair or glasses, mid-late 20s, in uniform. PO3: Black male, short, in blue uniform. A search of the BADS database reveals [REDACTED]'s arrest, [REDACTED] His arresting officer was PO Maurice Harrington of the 52 PCT.
