Initial Complaint Narrative

On February 11, 2009, at approximately 10:51 p m., Capt. O'Sullivan called IAB to report that officers responded to [REDACTED] in the Bronx, to a call for assistance involving an emotionally disturbed person. When the officers arrived at the location, a young male, [REDACTED] (DOB [REDACTED]) held a stick and swung it at the officers. The young man's mother, [REDACTED] interfered when the officers attempted to arrest him. [REDACTED] was subsequently arrested for OGA and resisting arrest. [REDACTED] complained of injuries. On February 11, 2009, at approximately 11: 31 p.m., Sgt. Ivan Gonzalez from the 42nd Precinct called IAB and reported that [REDACTED] complained of pain in her right jaw, back, right thigh, and her wrist. [REDACTED] was taken to the hospital. On February 12, 2009, at approximately 1:29 a m., Sgt. Roselyn Greaux from the 42nd Precinct called IAB and reported that [REDACTED] was at the precinct. [REDACTED] did not have any broken bones and her injuries did not require stitches.
