Spanish Speaker*Two black male officers and a Hispanic female officer in uniform arrested [REDACTED] in his girlfriend's apartment. [REDACTED] did not know why he was arrested and indicated that officers "dragged" him and "beat him up". Officers also pepper sprayed [REDACTED] in his mouth when he asked for his medication for a heart condition. [REDACTED] sustained a fractured knee and other unspecified injuries to his ankle, back and wrists and was taken to more than one hospital. There were unmarked vehicles at the location.
