### Case Summary

On June 11, 2011, § 87(2)(b) a resident of § 87(2)(b), called the NYPD Internal Affairs Bureau to file the following complaint. The case was assigned log number 11-27576 and was referred to the CCRB on June 21, 2011.

On June 11, 2011, at approximately 1:21 pm, § 87(2)(b) was being led out of the holding cell inside the 120<sup>th</sup> Precinct stationhouse in Staten Island by PO Christopher Eng and PO Daniel Pantaleo of the 120<sup>th</sup> Precinct when the officers allegedly struck his head against the holding cell, causing § 87(2)(b) to sustain a laceration. § 87(2)(b) also alleged that the officers kicked and punched him while leading him out of the cell. § 87(2)(b) received medical treatment at § 87(2)(b), where he received nineteen stitches and two staples to close the laceration to his forehead. § 87(2)(b) was charged with assault in the second degree and criminal possession of a weapon in the fourth degree, amongst other charges. At the time of this report, § 87(2)(b) is incarcerated at the § 87(2)(b).

On June 22, 2011, the undersigned investigator received the case and mailed the first please call letter to § 87(2)(b). To date, this letter has not been returned to the CCRB by the US Postal Service. On July 1, 2011, after determining that § 87(2)(b) was incarcerated, the investigator contacted § 87(2)(b)'s attorney, § 87(2)(b) of the Staten Island Legal Aid Society, at which time § 87(2)(b) refused to provide his permission for § 87(2)(b) to provide a statement to the CCRB.
