Initial Complaint Narrative

On July 13, 2011, at approximately 1:00 p m., [REDACTED] was driving when he was pulled over at the corner of [REDACTED] in the Bronx by PO McClain and two other officers. The officers all exited their vehicle with guns drawn and PO McClain approached and requested the license of registration of [REDACTED] he stated that they had stopped him for running a stop sign. PO McClain took these and returned to his vehicle. Meanwhile an additional patrol car arrived. After approximately 30-40 minutes, PO McClain returned and informed [REDACTED] that he could leave. [REDACTED] asked for PO McClain's badge number. PO McClain told [REDACTED] that he could give him back his license and registration and that he would put it on the summons. [REDACTED] did not want to receive a summons so he informed PO McClain of this and left. [REDACTED] subsequently went to the 41st Precinct stationhouse and spoke to PO Kennedy; he pointed out PO McClain to her and was informed of his name [REDACTED] [REDACTED] PO McClain: White male, short, med-heavy build, blond hair, 20-30 yrs old.
