Initial Complaint Narrative

██████████ and ██████████ rode in ██████████'s vehicle when they were pulled over by PO1 and PO2. PO1 explained that he saw ██████████ "looking into" ██████████'s white Ford Expedition, which was parked around the block; ██████████ denied this had happened. PO1 questioned ██████████ about his ownership of the white Ford Expedition. ██████████ replied, "If we were stopped in a black Acura, why are you questioning us about the white Ford Expedition?" ██████████ and ██████████ exited the vehicle and stood at the rear while PO1 searched the vehicle two times, locating a switchblade knife beneath the front passenger seat. PO1 became upset as ██████████ questioned his authority and said that ██████████ was under arrest for possession of the switchblade knife. ██████████ was released from the scene without summons or arrest; he drove away. Additional plainclothes officers arrived and ██████████ was transported to the 48th Precinct stationhouse, where he was charged with ██████████. His white Ford Expedition was impounded despite the fact that it was legally parked. ██████████ did not know ██████████ contact information at the time of filing his complaint, but believed that his legal surname might be "██████████". He provided ██████████'s license plate number as ██████████. PO1: Hispanic, male, 6'2", medium build, tan, black, 30's, PO2: male, Hispanic, lighter, 5'8", medium, 30's, low Cesar cut. He provided officer information "PO Miguel Frias, tax number ██████████" obtained from his property voucher.
