[REDACTED] stated that he witnessed from his third floor apartment ten (10) unidentified subject/officer's trying to handcuff a suspect. [REDACTED] stated that he told S/O: "Ten people on one guy, maybe you can put the cuff on". [REDACTED] stated that three unidentified subject/officer's came upstairs, kicked the door open, punched [REDACTED] in the neck, and kicked him in the ribs and called him "pussy". [REDACTED] described subject/officer# 1 as Dark skin, Black male, 6 feet, about 200 lbs. Subject/officer# 2 is described as Latino, caramel color, 5.8, 175 lbs, and subject/officer# 3 is described as White or light skin Latino.
