Initial Complaint Narrative

On June 27, 2012, at approximately 7:00 a.m., [REDACTED] was walking in the vicinity of [REDACTED], in Staten Island. Two police officers in plainclothes stepped out of a grey Buick, stopped [REDACTED] and identified themselves as police officers. PO1 was a white male in his mid-30s, between 5'8" and 5'9" tall, muscular, had tattoos on his arms and a bald head. PO2 was a white male in his early 30s, thin, about 190 pounds and had short dark hair. One of the officers told [REDACTED] that he saw him coming out of an unspecified building. [REDACTED] replied, "You're a fucking liar because I did not walk out of any building." The officers said that they saw him coming out an unspecified building, and [REDACTED] offered to go to the building and check the cameras. The officers did not respond and began frisking and searching [REDACTED]. The officers went inside his front and back pants pockets and his windbreaker pockets. [REDACTED] had gloves in his windbreaker and one of the officers took them out, squeezed them and put his fingers inside. PO2 patted down [REDACTED]'s legs and told him to slip his feet out of the shoes, and [REDACTED] complied. PO2 ran his hands on [REDACTED]'s feet. [REDACTED] said that there were three witnesses who worked for a nearby store. [REDACTED] did not know their names or contact information.
