## Initial Complaint Narrative

---

On July 18, 2012 at 12:31 p.m. near [REDACTED] in Staten Island, [REDACTED] was coming out of his house when a marked police van with tinted windows had made a right turn. When the van's passengers saw him, the vehicle's operator backed up into the block from which he had made the right turn. [REDACTED] entered his vehicle and began driving when the police van's operator pulled him over. Three officers stepped out of the vehicle and PO1 told [REDACTED] he was stopping him because he had a broken tail-light and requested his license. [REDACTED] then told PO1 that he was among the same officers who had arrested him previously for illegal possession of morphine pills. PO1 asked [REDACTED] if he had morphine pills, to which [REDACTED] denied, stating, "What do you think, I'm stupid?". One of the officers then asked [REDACTED] to exit the vehicle and face the other way. One of the officers then patted him down, searching all four of his pockets and groin before separating his butt cheeks through the outside of his pants. The officers then opened [REDACTED] car doors and searched his vehicle. [REDACTED] did not see where in the car the officers had searched. [REDACTED] friend's wife was across the street and witnessed the incident. No arrest or summons issued.
