Initial Complaint Narrative

On July 11, 2016, [REDACTED] contacted the CCRB's Call Processing System stating that between 10:30 p.m. and 11:00 p.m. on July 10, 2016, her nephew, [REDACTED] was riding an electric scooter in the vicinity of [REDACTED] in Brooklyn. When [REDACTED] saw a marked police vehicle, he got off of the scooter and gave it back to the "little boy" that the scooter belonged to. PO1 and PO2, both of whom are from the 73rd Precinct stationhouse, came behind [REDACTED] in their patrol car and tased him, causing him to be taken to the hospital. When [REDACTED] arrived at the 73rd Precinct stationhouse, an officer said "fuck you" to [REDACTED]. PO1 told her to get out of his precinct. [REDACTED] does not know where [REDACTED] is. She was told that [REDACTED] was at central booking. She has been at central booking all day and has yet to see [REDACTED]. At about 10:36 a m., [REDACTED] got a call from someone at central booking informing her that [REDACTED] was just getting there and that they did not know where he had been and why he was just getting there. PO1: white, male, light colored hair, ~6'0" tall PO2: white, male, ~6'0" tall PHONE STATEMENT: On July 11, 2016, [REDACTED] was contacted at [REDACTED]. She provided the following statement to the CCRB via telephone. [REDACTED] reported that at about 10:30PM or 11:00PM on July 10, 2016, her nephew, [REDACTED] was riding an electric scooter back and forth down the block in the vicinity of [REDACTED] in Brooklyn. When [REDACTED] saw a marked police jeep occupied by three officers, he got off the scooter and returned the scooter back to the owner, [REDACTED]. [REDACTED] then drove away from the scene. The driver of the police vehicle, who [REDACTED] identified as "Lt. Landrum" or "Sgt. Landrum" by looking at his white or gold shield, tased [REDACTED] twice on his left side while he was still sitting inside the police vehicle. [REDACTED] who [REDACTED] believed was standing in front of [REDACTED] at the time he was tased, fell to the ground on his back and rolled to his side as he screamed out in pain. [REDACTED] noticed that two of [REDACTED] fingers were "slashed" while he was on the ground, but she did not know how he sustained the injury. [REDACTED] returned back to the scene after "Lt. Landrum" tased [REDACTED] and witnessed the remaining part of the incident. Lt. Landrum exited from the police vehicle followed by the officer who seated in the front passenger seat of the police vehicle (PO2) and the officer who was seated behind the front passenger seat (PO3). "Lt. Landrum" handcuffed [REDACTED] after which, PO2 and PO3 picked [REDACTED] up from the ground. [REDACTED] asked "Lt. Landrum" why he tased [REDACTED] and "Lt. Landrum" said it was because [REDACTED] was resisting arrest. [REDACTED] asked how [REDACTED] was resisting arrest and "Lt. Landrum" said the officers had been chasing [REDACTED] for about four blocks. [REDACTED] told "Lt. Landrum" to take [REDACTED] to the hospital. "Lt. Landrum" said [REDACTED] will be taken to the hospital after he is taken to the 73rd Precinct stationhouse. [REDACTED] called and requested that an ambulance respond to the stationhouse to attend to [REDACTED]. After [REDACTED] had been transported to the 73rd Precinct stationhouse, [REDACTED] went to the stationhouse with her brother [REDACTED] whose date of birth is [REDACTED] and [REDACTED] mother [REDACTED]. While [REDACTED] and [REDACTED] were standing in front of the front desk at the stationhouse, a uniformed white male officer (PO4) said, "I thought you said he (referring to [REDACTED]) was [REDACTED]-years-old." [REDACTED] said she never said this. PO4 then said, "Fuck y'all." "Lt. Landrum then told them to get out of the precinct. Lt. Landrum / Sgt. Landrum: white, male, ~6'0" tall, medium build, moustache, dark brown hair with a little bit of gray, driver, uniform - white shirt, white or gold shield PO2: white, male, ~5'8" or 5'9" tall, heavier than Sgt., clean shaven, dark colored hair, sat in the front passenger seat of the police vehicle, uniform officer PO3: white, male, ~5'8" or 5'9" tall, slim build, clean shaven, no more than 30 years old, dark brown hair, sat behind the front passenger seat of the police vehicle PO4: male, white, ~6'2" tall, medium build, moustache, dark brown with a little red hair, regular uniform,
