Initial Complaint Narrative

On July 15, 2016, at approximately 6:00pm, in the vicinity of [REDACTED] and [REDACTED] in the Bronx, [REDACTED] was on his way the train station to meet his wife when he was stopped by PO1 and PO2. PO1 frisked [REDACTED] on the street, touched his buttock and told him that he felt something. [REDACTED] was then handcuffed and placed in the back seat of an unmarked van. PO1 laid him face down on the seat and proceeded to pull down his pants and underwear. PO1 searched him sexually grabbing his genitals and buttock. PO1 found a bag of marijuana in his buttock. [REDACTED] was then taken to PSA7 where he asked PO1 if he was going to issue him a DAT. PO1 then asked, "If you have cash, I can work something out and maybe give you a DAT." [REDACTED] then offered \$25 to PO1 and PO1 then said, "What about my supervisor?" [REDACTED] then told him that he could give him \$100 and that was all he could afford. PO1 asked if it was \$100 each and [REDACTED] told him that he could only afford \$100 for both. He then handed PO1 the \$100. PO1 left and did not return with the DAT. [REDACTED] was then taken to central booking and charges with bribing an officer and for possession of a controlled substance (angel dust). [REDACTED] reported that he received a property voucher for the \$400 that he had on him but has to wait until the case is over to retrieve it. The arresting officer listed in the property voucher was PO Michael Cautillo, Tax registry [REDACTED] PO1: male, white, 5'6" tall, muscular build, clean shaven, very aggressive, in uniform PO2: female, Hispanic, 5'3" tall, average build, in uniform, 150 pounds
