## Initial Complaint Narrative

On April 1, 2018, IAB called [REDACTED] [REDACTED] in regards to a complaint she filed with 311. On March 31, 2018, [REDACTED] walked outside and observed an altercation between the police and her son, [REDACTED]. Several officers were on top of [REDACTED] attempting to handcuff him. [REDACTED] was bleeding from his lip. After being handcuffed, two officers searched [REDACTED]'s pockets in the street. Later in the day, [REDACTED] went to the 73rd Precinct stationhouse and was informed by the arresting officer, PO Aponte, that [REDACTED] had pushed him.
