Case Summary

On May 8, 2018, this complaint was submitted by Sergeant Joseph Faello of Bronx Narcotics on behalf of § 87(2)(b) and § 87(2)(b) to the Internal Affairs Bureau (IAB) via telephone. It was received by the CCRB on May 16, 2018. On July 6, 2018, a spin-off (CCRB Case # § 87(2)(b)) was created which pertained solely to the allegations made by § 87(2)(b). This case pertains only to the allegations made by § 87(2)(b).

On July 2, 2018, § 87(2)(b) called and stated that he wanted the CCRB to communicate through his attorney. On July 5, 2018, § 87(2)(b)'s attorney, § 87(2)(b), called and scheduled § 87(2)(b) for an interview appointment at her office in the Bronx on July 11, 2018. On July 11, 2018, CCRB investigators went to § 87(2)(b) office but § 87(2)(b) missed his interview appointment without calling in advance to cancel or reschedule. At that time, § 87(2)(b) scheduled him for a second interview appointment at the CCRB on July 25, 2018. On July 25, 2018, § 87(2)(b) missed his second interview appointment without calling in advance to cancel or reschedule.

A search of the New York City Department of Correction website on July 25, 2018, indicated that § 87(2)(b) was not incarcerated. No video footage was obtained for this incident.
