[REDACTED] filed this complaint in person at the 52nd Precinct. Her report was translated, and PO Abbasciano faxed this report to the CCRB on 05/21/2018**Officers stopped [REDACTED] at [REDACTED] in the Bonx, and alleged that [REDACTED] was drunk and did not know how to drive. PO1 asked for her license and registration. PO1 later took [REDACTED] out of the car and told her to blow on a device. Later PO1 told [REDACTED] that she was under arrest, and called for many units, and took [REDACTED] to a precinct stationhouse. Before PO1 took her to the precinct, he broke the window of my car by pulling the driver side door aggressively. When she was at the precinct stationhouse, they did an exam on her and said that everything came out negative. And that in twenty minutes she would go home from the 46 Precinct. PO1 only gave [REDACTED] a summons, he said that he does not believe in God and that the Jewish race is superior.Then he started making fun of her, and said that she was still drunk.
