Initial Complaint Narrative

On June 25, 2018, [REDACTED] filed this complaint with the CCRB against the NYPD citing a pattern of harassment. On June 20, 2018, at an unspecified time, [REDACTED] was standing in front of Yankee Stadium in the Bronx, where he was waiting for his son, [REDACTED]. [REDACTED] was at the location to watch a baseball match. He was approached by a male who wanted to buy a ticket, to which [REDACTED] responded that he would sell it for the price that was on the ticket. [REDACTED] was then approached by several plainclothes officers, at which time he placed the ticket inside his sweatpants next to his testicles. PO1 reached into [REDACTED]'s pants, squeezed his testicles and retrieved the ticket in the process. PO1 then remarked that said ticket smelled like [REDACTED]'s testicles. [REDACTED] was taken into custody at the location. [REDACTED] noted that PO1 was also present during an incident on April 6, 2018, in which he was also arrested outside of Yankee Stadium for scalping tickets.
