## Initial Complaint Narrative

---

On August 13, 2018, [REDACTED] [REDACTED] filed this walk-in complaint with the CCRB: On August 11, 2018, at approximately 1 p.m., [REDACTED] and his friend, [REDACTED] went to the Yankee Stadium stationhouse to retrieve his property which was vouchered due to his prior arrest on August 10, 2018. [REDACTED] met with PO Edward McClain, who said, "Hey my asshole friend, hope you had a good night sleep." PO McClain gave [REDACTED] [REDACTED] his property and [REDACTED] [REDACTED] and [REDACTED] left the stationhouse. The two men boarded the Bx6 bus, located a few feet away from the stationhouse, but just when the bus was about to leave, PO McClain stopped the bus. PO McClain accused [REDACTED] of failing to pay his bus fare. The bus driver confirmed that [REDACTED] paid his fare, at which point PO McClain exited the bus and the bus left.
