Initial Complaint Narrative

On Thursday, December 6, 2018, [REDACTED] called the CCRB to file this complaint. On Tuesday, December 4, 2018, between 5:45 p.m. and 6:00 p.m., at [REDACTED] in the Bronx, [REDACTED] used his iPhone X to record his friend, [REDACTED]'s arrest. About six to seven police officers were present. While [REDACTED] was on the ground, an unidentified male police officer (PO 1) used his police radio to hit [REDACTED] in the face while two other unidentified male police officers (PO 2, PO 3) kicked him. [REDACTED] sustained a fractured right jaw. As [REDACTED] was recording [REDACTED]'s arrest, one of the officers approached [REDACTED]. In response, [REDACTED] pointed his phone towards the officer. One of the officers "jumped" [REDACTED] and attempted to break his phone. Another officer grabbed [REDACTED] threw him on the ground, and bent his arms back to handcuff him. [REDACTED] stated that the officers were pushing and pulling him while on the ground. The officers pulled [REDACTED] by his neck or hoody collar and then they held his arms as they lifted him up. Approximately three officers pushed him forward towards the police van. The officers grabbed [REDACTED] neck and pushed his head down while they held both of his arms as they were walking towards the police van. Both [REDACTED] and [REDACTED] were placed in a black van then driven to the 44th Precinct stationhouse. [REDACTED] went to the Bronx Central Booking and was released the next day, December 5, 2018, at approximately 8:30 p.m. [REDACTED]'s arrest status is not known. The police department is holding [REDACTED] iPhone for an investigation. [REDACTED] was charged with disorderly conduct, harassment, and possession of a controlled substance. [REDACTED] acknowledged that he had one pill of Oxycodone (prescribed medication) [REDACTED] stated that that the officer who handcuffed him was a Hispanic man, approximately 33 years old, 5'9" tall, short, black hair, styled, Cesar cut, wore a Nike red hoody, dark jeans. PO 1: African American man, bald, 38 to 41 years old, 6'3" tall, 220 to 230 pounds. Wore blue jeans, black sneakers, black hoody, and black skull. PO 2: white man, bald, 47 years old. Wore blue shirt and hoody, blue dark denim jeans. PO 3: African American or Hispanic man, bald, mid-40 to 45 years old, 6'1" tall, light blue jeans, black hoody, and skull.
