Initial Complaint Narrative

On March 10, 2019, [REDACTED] filed this complaint via the online complaint system: On March 9, 2019, at approximately 2:45 p.m., [REDACTED] parked his rental vehicle at [REDACTED] in the Bronx. After, he exited the vehicle and walked around it to make sure he was not on the curb or in the pedestrian walkway. As he walked back to the driver side, PO1 and PO2 approached him. While dealing with [REDACTED] PO1 and PO2 demonstrated abuse of their authority and excessive use of force. The officers allegedly lied about what transpired during the interaction and they arrested him after "provoking" him. While at the stationhouse, PO1 and PO2 refused to provide [REDACTED] their names and shield numbers. PO1: "Detective Schwartz," male, black, in uniform, brown eyes, bald head, 5'10"-6'0", heavy set PO2: "Ronald Hobson," male, black, 6'0", bald head, in uniform
