## Initial Complaint Narrative

---

On May 22, 2019, [REDACTED] provided the following narrative via phone. On May 8, 2019, at 4:00pm, at § 87(2)(b) [REDACTED] in Brooklyn, [REDACTED] was in a vehicle with [REDACTED] who stopped to pick up two other individuals. Police then stopped [REDACTED] and stated that the vehicle smelled like marijuana. [REDACTED] told the officers that he has an airsoft gun in his vehicle. The officers then asked all the individuals to step out the vehicle while they searched the vehicle. [REDACTED] and everyone else were taken to the 73rd Precinct stationhouse. [REDACTED] and two unknown individuals were released at 10:00pm without any summonses. [REDACTED] was held for two days before being released. [REDACTED]'s father went to the stationhouse to obtain the officers' names and shields. [REDACTED] is mainly upset that he was not read his rights and that he was not allowed a phone call.
