**Case Summary**

On May 22, 2019, § 87(2)(b) filed the following complaint with the CCRB via phone.

§ 87(2)(b) and § 87(2)(b) were all arrested as a result of the incident and § 87(2)(b) is facing criminal charges as a result. On June 03, 2019, the investigation contacted § 87(2)(b) who provided contact information for his attorney, § 87(2)(b). On June 04, 2019, § 87(2)(b) contacted the undersigned and said that he spoke with § 87(2)(b) and they decided he would hold off on providing a statement to the CCRB until the conclusion of his criminal case. On June 06, 2019, § 87(2)(b) contacted the investigation and said that he too, would hold off on providing a statement until the conclusion of § 87(2)(b)'s criminal case. Between July 03, 2019 and August 15, 2019 two letters and two emails were sent to § 87(2)(b) and five phone calls were made to the only phone number the investigation was able to find listed to him. Two letters were also sent to § 87(2)(b) and five calls were placed to him at one phone number and three calls were placed to another phone number, which did not appear to be functional.
