Case Summary

On May 30, 2019, **Str(2)** filed this complaint with IAB (log no. 2019-21778). This complaint was subsequently received by the CCRB on June 10, 2019. The CCRB obtained dashboard camera footage of this incident.

Between June 18, 2019, and July 3, 2019, the CCRB attempted to reach \$7(2)(b) by telephone on two occasions, and left a voicemail at each attempt. On July 10, 2019, the CCRB reached \$7(2)(b) by telephone and confirmed his contact information. \$7(2)(c) scheduled an appointment to provide an in-person statement at the CCRB on July 15, 2019. On July 15, 2019, \$7(2)(c) failed to appear at the CCRB for his scheduled appointment, and did not first call to cancel or reschedule. Between July 19, 2019, and July 24, 2019, the CCRB attempted to contact \$7(2)(c) by telephone on two occasions, and left a voicemail at each attempt.

Between July 19, 2019, and July 29, 2019, the CCRB mailed **\$37(2)(b)** three unreturned letters.

On July 29, 2019, a search of the New York City Department of Corrections inmate lookup website revealed that \$87(2)(b) is not currently incarcerated.
