Initial Complaint Narrative

On August 3, 2019, a 911 operator called the IAB Command Center (original log number 19-29780) and connected [REDACTED] who filed this complaint, which was subsequently received at the CCRB on August 9, 2019. On August 3, 2019, at approximately 12:37 a.m., in the vicinity of Livonia Avenue and Powell Street in Brooklyn, plainclothes officers, who had been moving in the opposite direction of his vehicle and made a U-turn, stopped the vehicle in which [REDACTED] was an occupant. During the incident, [REDACTED] did not authorize officers to search his person or vehicle. Summons number § 87(2)(b) for § 87(2)(b) was associated with this incident.
