Initial Complaint Narrative

Phone Narrative: On August 8, 2019, at 6:00pm, at § 87(2)(b) in Brooklyn, § 87(2)(b) was celebrating his mother § 87(2)(b)'s birthday in the backyard. § 87(2)(b) heard some noise coming from the apartment and peeked inside and saw PO1 kicking in his door. § 87(2)(b) told his mom the police were here. § 87(2)(b) went into the home to speak with the officers. Immediately everyone was arrested besides § 87(2)(b) who went upstairs. § 87(2)(b) came back down with his hands in the air. Officers pointed their guns at his face and placed him onto the floor. § 87(2)(b) was worried about the officers pointing their guns at her son. PO2 then used his Taser on § 87(2)(b). Everyone was taken to the stationhouse and all charges were dismissed before seeing a judge besides § 87(2)(b) whose case was later dismissed after seeing the judge. § 87(2)(b) stated that their home was searched while everyone was incarcerated and a rifle and bullets were found. § 87(2)(b) believed there was over a dozen officers at the scene. PO1: Male, Hispanic, 5'1", slim build, bald, always wears hat backwards, plain clothed. PO2: Male, white, 6'2", slim build, goatee, blonde hair, plain clothed.
