Initial Complaint Narrative

THE ORIGINAL LOG # 19-33832 WAS ASSESSED AS AN (FI-201). THIS IS A SPIN OFF CCRB "FADO-FORCE ALLEGATIONS. A buy and bust operation took place front of § 87(2)(b) in the Bronx involving two males, § 87(2)(b) and [REDACTED]. An undercover officer purchased marijuana from the two perpetrators and signaled a confirm buy to the field team. The field team attempted to apprehend the perpetrators, at which point they attempted to flee on foot. Detectives Vasquez, Brown, and Toribio gave chase after [REDACTED]. As they came in close proximity of [REDACTED], a scuffle ensued, which subsequently resulted in a forcible takedown and [REDACTED] being placed in handcuffs. [REDACTED] alleged that the detectives used excessive force, causing him to sustain a headache. He was taken § 87(2)(b), treated, and released with Motrin for the headache. Detectives Mede and Jaquez chased after [REDACTED] as he ran into the lobby of § 87(2)(b) and attempted to run up a flight of stairs. Detective Jaquez was able to grab him, at which point both of them fell backwards from the staircase onto the ground. A scuffle ensued, which subsequently led to [REDACTED] being placed in handcuffs. [REDACTED] told § 87(2)(b) "Go to the hospital, we are going to get paid." [REDACTED] complained of pain and minor scratches to his face, and he was transported to § 87(2)(b).
