Initial Complaint Narrative

On January 30, 2020, § 87(2)(b) called the CCRB to file a complaint on behalf of one of his employees § 87(2)(b). § 87(2)(b) did not witness the incident, but wanted to file a complaint because § 87(2)(b) was incarcerated at the time of calling. On January 29, 2020, at an unknown time, at an unknown location in Manhattan, § 87(2)(b) was approached by individuals in plain clothing who stated they saw § 87(2)(b) smoking/sniffing a "bag of dope". § 87(2)(b) did not know they were officers and got into a verbal argument with the individuals which ended up becoming physical. Both parties threw punches and pushed/shoved each other. The individuals eventually identified themselves as officers and arrested § 87(2)(b) and took him to the hospital for the injuries from the physical interactions. § 87(2)(b) spoke with § 87(2)(b) legal aid lawyer who stated he was charged with § 87(2)(b).
