Initial Complaint Narrative

On February 4, 2020, [REDACTED] filed this complaint with the CCRB via phone. On February 4, 2020, at 3:50 pm, [REDACTED] was pulled over while driving at East New York Avenue and Junius Street in Brooklyn. PO Vincent Dandraia and PO1 approached him and asked for his documents. Before he could provide them, PO1 asked him to step out of the vehicle as it smelled like Marijuana. [REDACTED] complied and the officers proceeded to search his vehicle. The officers went through his glove compartment, several bags of clothing and broke the lock to his safe while searching it. They then told him he was free to go as they did not find any Marijuana. He was not issued a ticket.
