### Case Summary

On February 4, 2020, § 87(2)(b) filed this complaint with the CCRB via phone. § 87(2)(b) provided his name, address, phone number, date of birth, but refused to provide an email address. He elected to receive text message reminders. The undersigned received this case on February 5, 2020. No video footage was obtained for this incident.

During his intake call, § 87(2)(b) scheduled an in-person interview at the CCRB for February 10, 2020. On February 8, 2020, § 87(2)(b) was sent a text message reminder for his interview. On February 10, 2020, § 87(2)(b) failed to appear for his interview and did not give any prior notice nor attempt to reschedule. On that same day, the undersigned mailed a missed appointment letter to § 87(2)(b). Between February 11 and 19, 2020, the undersigned called § 87(2)(b) three times and each time left a voicemail message requesting a call-back. On February 18, 2020, a please call letter was mailed to § 87(2)(b). On February 21, 2020, the undersigned called § 87(2)(b) and scheduled him for a second interview for February 26, 2020. On February 24, 2020, a text message reminder was sent to § 87(2)(b). On February 26, 2020, § 87(2)(b) failed to appear for his second attempted interview and did not give any prior notice nor attempt to reschedule.

Searches of the Department of Corrections websites for New York City and New York State on March 3, 2020 both confirm that § 87(2)(b) is not currently incarcerated nor was he incarcerated during the contact attempts. § 87(2)(g)
