## Initial Complaint Narrative

---

On May 31, 2020, § 87(2)(b) filed this complaint with the CCRB via the agency's website, as reflected in online complaint #1-1-7982734: On May 30, 2020, at approximately 8:55 p.m., § 87(2)(b) was at Union Square in Manhattan where protests were being held. A line of officers were instructed to "push back" protestors and they told a large crowd of protestors to disperse. § 87(2)(b) then witnessed PO1 forcefully kick an empty trash bin into a small group of protestors who were walking away from the officers in an attempt to disperse. PO1: male, white, 6'+, brown/black hair, close-set eyes, large nose, uniform, shield number 929
