Initial Complaint Narrative

On June 1, 2020, [REDACTED] called the CCRB to file the following complaint: On May 30, 2020 at approximately 12:18 AM, [REDACTED] called IAB to make a complaint against officers from PSA2 and the 73rd Precinct for not showing up to his numerous calls for assistance. [REDACTED] has been calling for police assistance because of drug dealers, people fighting, and gun shots happening in his area. [REDACTED] has called several times for help but officers never showed up. [REDACTED] called IAB to make a complaint and spoke with PO Soto. PO Soto told [REDACTED] that he will not make any new complaints for him and will add it to an existing complaint, Case #20209493. PO Soto then hung up on [REDACTED]. [REDACTED] called IAB again and spoke with PO Romano. PO Romano also refused to generate a new complaint for [REDACTED] and hung up on him. [REDACTED] called IAB again and spoke with PO Soto. PO Soto again refused to generate a new complaint for [REDACTED] and told him that it would be added to a previous complaint. PO Soto also told [REDACTED] that IAB will no longer generate new complaints for him. [REDACTED] called IAB again and spoke with PO Cortez who also refused to generate a new complaint. [REDACTED] noted that once COVID-19 is over he will be taking all his records to the Mayors Office and have them subpoena CCRB's records since the CCRB does not help him.
