### Initial Complaint Narrative

On May 30, 2020, at approximately 11:48 PM, 1 several sectors responded to radio runs regarding large groups of individuals. Officers were attempting to form a line to flush a group from the corner of West 114th Street & 8th Avenue, when one of the persons in the group, § 87(2)(b) became insistent of not leaving standing in front of PO Hummel, Tax# 950604, 28th Precinct. § 87(2)(b) squared off and took a fighting stance, when PO Hummel punched § 87(2)(b) in the face. PO Hummel attempted to handcuff § 87(2)(b) when objects were thrown at them. PO Hummel and § 87(2)(b) were hit in the head with alcohol bottles. PO Hummel received 7 staples to his forehead and a broken pinky finger. § 87(2)(b) was removed and admitted to § 87(2)(b)
