## Initial Complaint Narrative

---

The following complaint was obtained via IAB Log [REDACTED] (Original Log # [REDACTED]: On Saturday May 30, 2020, at approximately 3:50 PM, IAB received a telephone call from 911 operator # [REDACTED] who was on the line with an anonymous complainant (anonymous # [REDACTED]). The anonymous complainant stated that on May 30, 2020, at approximately 3:30 PM, she (the complainant), her daughter and her daughter's boyfriend were having a verbal dispute with the owner of a local laundromat, located at [REDACTED] (confines of 106th Precinct). The complainant called 911 (which generated ICAD # [REDACTED]), and PO Young [REDACTED] and PO Cutler [REDACTED] (assigned to the 106th Precinct) responded. The complainant and her daughter's boyfriend (it is unclear if the boyfriend was also on the call) stated that PO Young "nudged" the complainant's daughter (IAB specified that "nudged" meant "pushed without excessive force," but it is unclear where that specification came from) because he (PO Young) thought that the complainant's daughter was "getting aggressive" with the owner of the laundromat. The complainant's daughter's boyfriend stated that he told PO Young, "She's only 100 pounds. Do that to a man, not a girl. Push me like that, I bet you won't, you're a grown man." PO Young removed his shield from his uniform and placed it on top of the hood of the police car. The boyfriend was unsure if PO Young removed his body-worn camera. The boyfriend told PO Young, "Either way, with your badge or not, I'm not going to hit you because I'll get arrested." PO Young and PO Cutler went into the police vehicle. PO Young said, "You're all talk," over the loudspeaker and the officers drove away. The complainant told IAB that PO Young allowed her to take a picture of him with his hands displaying a "peace sign." She told IAB that she would email the picture to the Command Center desk. A DASLITE query yielded ICAD # [REDACTED], which had a final disposition of [REDACTED]. An AXON BODYWORN CAMERA query yielded negative results for PO Young, Tax# [REDACTED] and PO Cutler, Tax# [REDACTED].
