### Initial Complaint Narrative

On June 1, 2020, § 87(2)(b) submitted this complaint with IAB generating IAB Log #20-13961 At approximately 2:30 p.m. on May 30, 2020, § 87(2)(b) was attending a protest in the vicinity of Park Avenue and East 82nd Street in Manhattan. An officer, PO Wright, while waving his straight baton approached § 87(2)(b). As PO Wright approached, § 87(2)(b) moved backward until she had her back against a parked vehicle. § 87(2)(b) was frightened and alarmed. PO Wright told § 87(2)(b) "Get the fuck back." PO Wright used the word "fuck" multiple times.
