Case Summary

§ 87(2)(b) filed this complaint via the CCRB’s online website on September 26, 2021.

This case was originally assigned to Inv. Laura Strauss. On September 29, 2021, Inv. Strauss reached § 87(2)(b) by telephone. § 87(2)(b) confirmed his contact information and scheduled an interview appointment for October 8, 2021. An automated SMS interview appointment reminder was sent to § 87(2)(b) on October 7, 2021. However, he did not answer either of two calls Inv. Strauss placed to him on October 8, 2021. Inv. Strauss left voicemail messages. Inv. Strauss sent a “missed appointment” email to § 87(2)(b) on October 12, 2021 and left a third voicemail message for § 87(2)(b) on October 12, 2021.

This case was reassigned to Inv. Ross on October 18, 2021. On October 20, 2021, Inv. Ross left a fourth voicemail message for § 87(2)(b) and sent a second email. A fifth voicemail message was left on October 25, 2021. On October 25, 2021, Inv. Ross reached § 87(2)(b) by telephone. He scheduled an interview appointment for October 28, 2021. An automated SMS interview appointment reminder was sent to § 87(2)(b) on October 26, 2021. However, § 87(2)(b) did not answer when called for his October 28, 2021 interview appointment, and he did not call back. A sixth and final voicemail message was left for § 87(2)(b) and a third and final email sent, on November 1, 2021.

On November 3, 2021, a search of the New York City Department of Correction database confirmed that § 87(2)(b) is not incarcerated.
